The City Attorney's Office-Utilities Division will present a draft Decision and Order and draft Resolution for the Open Access Transmission Tariff (OATT) Revisions based upon the June 28, 2022 public hearing held for Colorado Springs Utilities' OATT filed on May 24, 2022.
