The City Attorney's Office-Utilities Division will present a Decision and Order and Resolution for the 2021 Wastewater Rate Case based upon the October 27, 2020 public hearing held for Colorado Springs Utilities' 2021 Rate Case filed on September 22, 2020.

Background:

On September 22, 2020 Colorado Springs Utilities submitted a 2021 Rate Case filing that included proposed changes to a Wastewater Rate Schedule effective January 1, 2021. In accordance with Colorado Springs City Code § 12.1.108, City Council held a public hearing on October 27, 2020 regarding Colorado Springs Utilities' 2021 Wastewater Rate Case.
