Background:

Yearly, a report will evaluate whether objectives are being achieved by reporting on: Keystone Indicators and other measures of success; progress on recommended major city initiatives; experience with the development review process; and if there are any recommendations for realignment of strategic city priorities related to the Plan. 2020 is the second year of the plan's implementation, and the 2020 annual report makes a few adjustments in layout to focus more on
