A public hearing will be conducted for City Council to consider proposed changes to Colorado Springs Utilities' Utilities Rules and Regulations as reflected in the 2020 Mid-Year Rate Case filing to be effective August 1, 2020

Background:

On May 26, 2020 Colorado Springs Utilities filed the 2020 Mid-Year Rate Case, including a resolution and all supporting documentation, that proposed changes to the Utilities Rules and Regulations to be effective August 1, 2020.

In accordance with the City Code of the City of Colorado Springs § 12.1.108, copies of the rate filing were available for public inspection in the City Clerk office beginning on May 26, 2020. Notice of the proposed changes was provided by publication in The Gazette on May 30, 2020. The 2020 Mid-Year

Rate Case filing was also posted on the Colorado Springs Utilities' website at www.csu.org, and electronic copies were provided to City Council members.

As part of the hearing and at the direction of the Utilities Board, Colorado Springs Utilities will request suspension of Part 4 1(C) of the Rules and Procedures of City Council to allow for the waiver of a Decision and Order and facilitate consideration of the tariff proposal and revisions directly following the conclusion of the public hearing.

Previous Council Action:

On November 12, 2019 City Council approved the most recent changes to the Utilities Rules and Regulations by Resolution No. 123-19. On May 26, 2020 City Council established a public hearing date of July 14, 2020.
