In accordance with Colorado Springs City Code § 12.1.107, City Council held a public hearing on June 14, 2016 regarding Colorado Springs Utilities' 2016 Electric Rate Schedule, Industrial Service - Time-of-Day 1,000 kWh/day Minimum (ETL) rate case.
