# Summary:

Applicant: Land Development Consultants, Inc. Owner: Ruth Bowen Location: Southeast corner of Ruby Drive and Silver Drive

This is a request to approve a resolution finding the Bowen Addition Annexation petition to be in substantial compliance with C.R.S. section 31-12-107, setting a public hearing date of February 28, 2017 to consider the annexation, and directing the City Clerk to provide notice of the hearing in accordance with C.R.S. section 31-12-108. The annexation area is .849 acres and located at the

southeast corner of Ruby Drive and Silver Drive

## **Previous Council Action:**

On August 9, 2016, City Council accepted the original petition for annexation.

#### **Background:**

The Colorado Municipal Annexation Act of 1965 (the "Act") provisions require that once a petition has been reviewed and is found to be in substantial compliance with the requirements of C.R.S. 31-12-107(1), the City Council must set a hearing to consider the annexation and publish notice of the annexation hearing for four (4) weeks prior to the public hearing. In addition, the hearing date must be no less than thirty (30) days or more than sixty (60) days after the effective date of the resolution setting the hearing. City staff has reviewed the Bowen Addition Annexation Petition and has found it to be in substantial compliance with C.R.S. section 31-12-107(1). City staff recommends that City Council find the petition to be in substantial compliance, set a hearing date on the petition, and direct the Clerk to give notice in accord with C.R.S. section 31-12-108, as required by the Act. The notice of the annexation hearing can be published on the following dates: January 28, 2017, February 4, 2017, February 11, 2017 and February 18, 2017 to adhere to the statutory requirements for the February 28, 2017 City Council meeting. Approving the resolution and setting a public hearing for the proposed annexation does not obligate the City Council to approve the annexation in the future.

## **Financial Implications:**
