#### Summary:

City Charter Article III, Section 3-10(e) requires that Council appoint by the concurring vote of a majority of its members a City Council Administrator, whose duties, compensation, and tenure of office shall be as prescribed by ordinance.

The proposed Ordinance would appoint Emily Evans as the City Council Administrator, as well as set her duties, compensation, and tenure in office. The proposed Ordinance provides that Emily Evans' effective date of appointment shall be November 28, 2018, and her salary shall be set at \$98,614 annually, together with all applicable benefits. The proposed Ordinance further provides that Emily Evans will fulfill the duties and responsibilities of the City Council Administrator as set forth in City Code Ch. 1, Art. 2, Part 10, and other applicable laws, rules or regulations.
