## Review and Approval of Decision and Order and Resolution Setting Electric Rates within the Service Area of Colorado Springs Utilities

#### **Summary:**

The City Attorney's Office-Utilities Division will present a draft decision and order and draft resolution for the 2017 Electric rate case based upon the October 25, 2016 public hearing held on Colorado Springs Utilities' September 13, 2016 rate case filing. #### Background:

On September 13, 2016 Colorado Springs Utilities submitted a 2017 rate case filing that included proposed changes to the Electric rate schedules to be effective January 1, 2017. In accordance with Colorado Springs City Code § 12.1.107, City Council held a public hearing on October 25, 2016
