A resolution finding a petition for annexation of the area known as Dublin North No. 4 Annexation consisting of 10.91 acres to be in substantial compliance with section 31-12-107(1), C.R.S. and setting a hearing date of August 14, 2018 for the Colorado Springs City Council to consider the annexation of the area.

Summary:

This is a request to approve a resolution finding the Dublin North No. 4 Annexation petition to be in substantial compliance with C.R.S. section 31-12-107, setting a public hearing date of August 14, 2018 to consider the annexation, and directing the City Clerk to provide notice of the hearing in

accordance with C.R.S. section 31-12-108. The annexation area is 10.91 acres and located northeast of Dublin Boulevard and Tutt Boulevard.

Previous Council Action:

On July 28, 2015, City Council accepted the original petition for annexation and deferred the internal review back to City staff.

Background:

The Colorado Municipal Annexation Act of 1965 (the "Act") provisions require that once a petition has been reviewed and is found to be in substantial compliance with the requirements of C.R.S. 31-12-107(1), the City Council must set a hearing to consider the annexation and publish notice of the annexation hearing for four (4) weeks prior to the public hearing. In addition, the hearing date must be no less than thirty (30) days or more than sixty (60) days after the effective date of the resolution setting the hearing. City staff has reviewed the Dublin North No. 4 Annexation Petition and has found it to be in substantial compliance with C.R.S. section 31-12-107(1). City staff recommends that City Council find the petition to be in substantial compliance, set a hearing date on the petition, and direct the Clerk to give notice in accord with C.R.S. section 31-12-108, as required by the Act. The notice of the annexation hearing will be published on the following dates: June 30, 2018; July 7, 2018; July 14, 2018; and July 21, 2018 to adhere to the statute requirements for the August 14, 2018 City Council meeting. Approving the resolution and setting a public hearing for the proposed annexation does not obligate the City Council to approve the annexation in the future.

Financial Implications:

A fiscal impact analysis has been prepared and will be provided to the City Council with the annexation hearing information packet.

Alternatives:

City Council can approve, modify or deny the resolution finding the petition to be in substantial compliance, setting the hearing date and directing the Clerk to give notice of the public hearing for the annexation.
