The City of Colorado Springs and El Paso County have been in discussions on a consolidation of their respective Offices of Emergency Management to create a Regional office. Consideration has been given to the facility, organizational structure, finance, human resources and a number of other areas. It is proposed that the City enter into a three-year intergovernmental agreement with El Paso County to regionalize emergency management functions. At the conclusion of the three-year period, the staff will report back to City Council on metrics, survey data and other factors related to the success of the effort.
