### Title

A Resolution Setting the Street Lighting Service Revenue Requirement for the Period of January 1, 2023 Through December 31, 2023

### Summary:

Colorado Springs Utilities (Utilities) requests City Council to set the Street Lighting Revenue Requirement for the provision of street lighting services from January 1, 2023 through December 31, 2023 in the amount of \$4,401,000.

### Background:

The street lighting infrastructure operated by Utilities within the City of Colorado Springs (City) is part of the system of utilities owned and operated for the convenience and necessity of the citizens of the City. Colorado Springs City Code § 12.9.103 authorizes Utilities to assess and collect a street lighting service charge from the City for the provision of street lighting services. Additionally, City Code § 12.9.105 requires Utilities to annually prepare a revenue requirement for the provision of street lighting service setting forth the amount that must be recovered for the provision of street lighting service pursuant to City Code § 12.9.103.

### Previous Council Action:

City Council set the Street Lighting Revenue Requirement for the period of January 1, 2022 through

December 31, 2022 with Resolution No. 151-21 dated November 09, 2021.

**Financial Implications:**

Utilities performed analysis of the Street Lighting Service Revenue Requirement and determined an amount of \$4,401,000 is required to recover expenditures for the provision of street lighting services from January 1, 2023 through December 31, 2023.
