Ordinance No. 83-88

AN ORDINANCE AMENDING THE ZONING MAP OF THE CITY OF COLORADO SPRINGS, RELATING TO 16.7 ACRES SITUATED WEST OF SOUTH ACADEMY BOULEVARD AND ASTROZON BOULEVARD

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. The zoning map of the City of Colorado Springs is hereby amended by rezoning the real property described in Exhibit A, attached hereto and made a part hereof by reference, from R-5 to C-6P, pursuant to the Zoning Ordinance of the City of Colorado Springs, subject to the following conditions and restrictions:

- 1. Curb cuts limited to: Academy (1) and Astrozon (3). The site will be served by an interior road which will intersect once with Astrozon and once with Academy. All development on this site will be accessed from this interior road.
- 2. 20 foot front building setback.
- 3. 10 foot front landscaping setback.
- 4. Screening of all outside storage (including garbage containers). This excludes the proposed used car lot which will be screened from the mobile home park across Sand Creek and from the other uses in the development.
- 5. A conceptual development plan showing proposed circulation and platting must be approved before platting is approved.
- 6. Final development plans must be approved before building permits are issued.
- 7. Uses and square footages of those uses are limited to those listed below:

One fast food restaurant	3,500 square feet
One sit down restaurant	4,000 square feet
One convenience store	3,500 square feet
Retail	19,000 square feet
Office, warehouse	90,000 square feet
One car wash	N/A
One bowling alley	N/A
One car dealership	N/A
