I live with my spouse in the neighborhood immediately adjacent to the Revolution Church. We are writing to oppose the variance requested by the church for a child care center and summer camp. We are very concerned about the effect that this will have on noise and traffic in an area that is zoned for single-family homes. We did not mind the church using the existing facility left from the YMCA, but a child care center and summer camp will drastically change usage and traffic from what it is currently.

We selected this location in part because of the relatively more quiet location compared with our last residence, and we would be very disappointed to lose that now when the zonation laws made us feel secure at the time we moved that the neighborhood would not see such changes. We are concerned in particular that noise will increase outside of standard business hours due to the nature of summer camps and after-school childcare. The local infrastructure is designed for the single-family homes that the area is zoned for, not for handling the volume of traffic that would be associated with these new facilities, and we are concerned about increased traffic congestion. Many households in the area rely on street parking that would become both less safe and less available with the increased traffic.

We also are concerned about the impact on our property values due to being well within earshot of such facilities, and in fact wonder if this could cause our home loan to go upside-down (i.e., we worry that we will owe more on the house than the house then would be worth). Increasing the number of non-residents that enter the community always carries with it increased risks for residents. The may include crimes like petty theft and vandalism, as well as vehicular accidents, accidental fires, and other unintended consequences.

For all of these reasons, we urge you to deny the variance requested by the Revolution Church. Thank you.
