I am writing to urge you to deny this project. Colorado Springs is known for its natural beauty, and these plywood apartments being approved are an eyesore. If you look at cities around the world, cheaply built plywood apartments are never a tourist attraction. We constantly hear that tourism is our largest employer, yet our city's reputation is suffering—not just in the U.S. but internationally. Violent crime in Colorado Springs is frequently mentioned on travel and social media sites. Unfortunately, I've experienced this firsthand, as many of my family members now refuse to visit.

Sorry for the late comments but please include these for the record.

I am opposed to the OneVela Development Plan and respectfully request that the Downtown Review Board deny the application.

Based on the Staff's Report, it appears there are still technical issues to resolved and despite Staff's confidence in getting those issues resolved, I think the DRB's hearing on the project should be delayed until they are resolved.

The following reasons for denial should be considered:

- 1. History of COS and Palmer's Vision where the Pikes Peak Mountain was the focal point and his donation of lands that guaranteed the natural landscapes would forever be open space and enjoyed by generations to come. We need to protect the character and uniqueness of our City. This includes our City's skyline.
- 2. We should keep the human scale of buildings which support walkability and a pedestrian friendly environment. Tall buildings reduce citizen access to fresh air and sunlight.
- 3. Environmental impacts are real. Mountains trap pollution and Pikes Peak, America's Mountain, is much closer to the City of Colorado Springs than the mountains are close to Denver.
- 4. Despite Staff's statement regarding the "street canyon" effect, I disagree as this project and others that will be built will contribute to significantly higher air pollutants in the downtown. In April 2023, the American Lung Association determined Colorado Springs ranks 20th in the nation for the worst ozone pollution.
- 5. OneVela does not address any affordable/attainable housing needs within the downtown core. In fact, it may drive apartment rents and property values up. Currently, there is a high vacancy rate for apartments in the downtown core.
- 6. The taxpayer's subsidies through the URA are troublesome since many proponents state this development is market driven but isn't viable without them.
- 7. Also, density doesn't necessarily equate to "vibrancy" and "energy and fossil fuel" efficiencies. I have not seen any studies on the subjective "vibrancy" argument. In fact, there is evidence to the contrary. Denver and Austin are two cities where the "vibrancy" argument can be disputed. Also, the efficiency argument has been challenged.
- 8. Lastly, response times for PD are at an all-time high and density will continue to strain our emergency resources. FD may need additional equipment to address skyscraper height.

Please deny this Development Plan.
