Ordinance No. 82-95

AN ORDINANCE AMENDING THE ZONING MAP OF THE CITY OF COLORADO SPRINGS, RELATING TO 53.39 ACRES SITUATED SOUTHWEST OF WOODMEN ROAD AND I-25

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. The zoning map of the City of Colorado Springs is hereby amended by rezoning the real property described in Exhibit A, attached hereto and made a part hereof by reference, from R-5, R, and PIP-1 to PIP-2, pursuant to the Zoning Ordinance of the City of Colorado Springs, subject to the following conditions and restrictions:

- 1. Commercial laundries, meat packing and processing, truck, tractor, trailer, bus storage yards or motor freight terminals and mini-warehouses not be permitted as allowed uses.
 - 2. Outside storage not be allowed as an accessory use.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by Charter.
