- 1: Car Wash businesses belong in a more commercial/industrial area and not in a neighborhood.
- 2: Have you ever seen an auto car wash place like this that is maintained and not a trash magnet? I haven't.
- 3: The traffic at that intersection is horrible enough already. During times in the morning and afternoon, cars can be backed up 1/4 mile or more on Peterson coming north. Going north on Peterson is also backed all the way past Pony Tracks trying to turn left onto N. Carefree. This means that cars can't access right and left turns onto Peterson from Pony Tracks as well because of congestion in that intersection.
- 4: We don't need another estimated 450 cars per day entering and exiting in addition to the above traffic.

To whom it may concern,

I received a green card in the mail about a proposed property going up in our neighborhood. The proposed development is an Autowash to be placed on 6783 N. Carefree Circle Colorado Springs CO 80922.

I would like to state my opposition to this project and relay a message that a carwash in this area would be an absolutely horrible idea. The primary reason for this is the safety of the children in this area. That corner is a very busy corner throughout the day as it is, due to Sandcreek High School being on that corner. There are so many children that walk to and from school. The proposal says there would be around 450 vehicle trips per 24hrs. We can very much assume that between the hours of 10pm and 7am there will be very little traffic. Generously saying there would be 25 during those hours means that from 7pm-9pm would average around 30 vehicles per hour with an already congested traffic due to the school. These added vehicles would not be a good thing as this additional traffic means more vehicles around kids walking. A year or so ago, we got one of these and this land was to be used for a "coffee shop". I understand that this is a business zoned area and at some point there will be a business on that land. If it is a coffee shop, that would be one thing. Kids could go there during their break, they could study while having a coffee etc. However, adding something to the land only to be utilize by added traffic would be detrimental to our community and the safety of the children of Sandcreek High School. Please DO NOT approve an Autowash going on this corner! It is far too dangerous!

Here is my response to the their response.

The response received does not answer but redirects the point of the danger of traffic you are adding. Traffic will naturally increase because of additional businesses being added to the corner. The main concern about a carwash is that these are not stop and stay a while, these are stop, wash and go. Kids currently walk though this field, around this field, on the sidewalks because of Sandcreek high school. The car wash projects a traffic count of around 430 cars. As such they will shoot low hoping for higher projections. 430 is a low projection. Like my original message said we can assume that the car was will see barely anything from the hours of 7pm to 7am. That means that on average we will have 35 cars in and out of the car wash per hour. 1 car every 2 minutes. There are way too many kids around to put the car wash on this corner. There is a corner across the street that may work, as it is bigger and more removed from the school. Even that though is a stretch as there is still plenty of child foot traffic. My message is simply about protecting kids. The Starbucks already took a sidewalk away from them, and will have added traffic in the drive through. We do not have the street infrastructure to support more traffic. Heather Glen is a perfect example of that. With all the cars parked on the street it has been come a one lane street. The streets in the area cannot support any more overflow traffic and regardless of what they say, the traffic will increase. No business is going to put something in that they don't expect to have growth. Again, I understand this is zoned for business. I am not opposed to all businesses coming in on this land. I think that certain other businesses could be great, and compliment that a school is close. A car wash does not do that. A car wash brings in potential accidents that this area does not need. Please do not allow them to build this car wash!
