## Ordinance No. 83-37

AN ORDINANCE AMENDING THE ZONING MAP OF THE CITY OF COLORADO SPRINGS, RELATING TO 22.2 ACRES SITUATED SOUTHWEST AND SOUTHEAST OF PIKES PEAK AVENUE AND INSTITUTE STREET

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. The zoning map of the City of Colorado Springs is hereby amended by rezoning the real property described in Exhibit A, attached hereto and made a part hereof by reference, from R-5, R-5 HR and R-2 to OC, pursuant to the Zoning Ordinance of the City of Colorado Springs, subject to the following conditions and restrictions:

- 1. That the existing High Rise Overlay on property north of Colorado Avenue shall be maintained.
- 2. That required street and intersection improvements be made as project phasing warrants.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by Charter.
