AN ORDINANCE AMENDING ORDINANCE NO. 22-90 (2023) APPROPRIATION BUDGET ORDINANCE) FOR Α SUPPLEMENTAL APPROPRIATION TO THE 2C2-ROAD REPAIR, MAINTENANCE AND IMPROVEMENT FUND IN THE AMOUNT OF \$16,000,000 FOR ADDITIONAL CAPITAL **EXPENDITURES IDENTIFIED FOR 2023**

Section 1.
