AN ORDINANCE REPEALING ORDINANCE NO. 23-46 AND APPROVING A SUPPLEMENTAL APPROPRIATION TO THE MEMORIAL HEALTH SYSTEM ENTERPRISE FUND IN THE AMOUNT OF \$1,465,848 FOR MONIES DUE TO UCH-MHS FOR THE PERIODIC RECONCILIATION WITH UC HEALTH

WHEREAS, on August 22, 2023, Council approved Ordinance 23-46, however, in Section 1 of Ordinance 23-46, the payee of the reconciliation transfer payment was misstated. Ordinance 23-46 must be repealed so that this corrected supplemental appropriation ordinance may be approved.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. That Ordinance No. 23-46 is hereby repealed.

Section 2. That Ordinance No. 22-90 is hereby amended by increasing the Memorial Health System Enterprise Fund expenditure appropriation in the amount of \$1,465,848 to transfer monies to UC Health-MHS. The source of funds is unrestricted fund balance.

Section 3. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 4. City Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance be available for inspection and acquisition in the office of the City Clerk.
