It is with great concern that I write to request that the Mountain Shadows Community Association and Westside Watch be granted equal time to present at the April 16, 2024 Planning Commission meeting regarding Arrowswest.

Putting this project forward is in direct violation of UDC Section 7.1.103 A as amended from 7.1.603.b that, as you are well aware, provides:

The purpose of this UDC is to:

A. Promote health, safety, and general welfare of the public;

Previously:

A proposal for the establishment or change of zone district boundaries may be approved by the City Council only if the following findings are made:

1. The action will not be detrimental to the public interest, health, safety, convenience or general welfare

Further, your decision to move this forward conflicts with the prior City Council decision and established Colorado Court of Appeals legal precedent specifically pertaining to this site.

The City Council previously ruled in the matter of 2424 Garden of the Gods that dense development at that very location (the intersection of Garden of the Gods and 30th Street) would jeopardize the health and safety of the residents.

This decision was upheld by the Colorado District Court AND the Colorado Court of Appeals.

We respectfully request equal time to present the expert findings that we have compiled with regard to residential development at this location so that the Planning Commission may have a complete picture of development risks and liabilities.
