Know all men by these presents that William B. Jenkins and John H. Bacon, being sole owners of Block One (1) and Lots 7 to 17 inclusive of Block Two (2), Lots 3 to 5 inclusive and the West thirty feet of Lot (2), Block five (5) all of which having been duly varied by an instrument bearing even date herewith, and a strip of land Three hundred thirty feet (330) wide running along the south edge of the North east quarter (NE 1/4) of North West quarter (NW 1/4) Section Thirty (30) beginning on the West line thereof and extending easterly to the North line of the North West quarter (NW 1/4) of Section Thirty (30) and all of the North West quarter (NW 1/4) of Section Thirty (30) of Township 36 North Range 66 West excepting therefrom a strip of land, beginning at a point on the south line of said North West quarter (NW 1/4) of Section Thirty (30) and running north at right angles to said south line Three hundred thirty (330) feet, thence east parallel to said south line One hundred and thirty (130) feet, thence south parallel to first course One hundred and thirty (130) feet, thence east at right angles One hundred (100) feet; thence south parallel to first course One hundred and thirty (130) feet to the said south line of NW 1/4 Sec 30, thence West along said south line Three hundred fifty (350) to the place of beginning, have this day plotted the above described lands to be known as Addition No 1 to Inymild, El Paso County Colorado according to the map or plat hereunto annexed, and the said William B. Jenkins and John H.
