Engagement Summary



OVERVIEW: With guiding input from a series of kickoff stakeholder focus groups in December 2023, the planning team initiated an online community survey to inform and educate the public on open space definitions and explore recreation and conservation perspectives for Colorado Springs' newest open space: Fishers Canyon Open Space. The survey was open to the public from February 23 through March 17, 2024 (three weeks).

Over 950 members of the community (mostly from the 80906 zip code) completed the online survey. As an undeveloped open space currently not open to the public, the survey questions explored topics of open space values and recreation desires. The survey also presented information on open space ("open space 101") to inform the public on the new open space and its importance as a key connection for the 26-mile Chamberlain Trail.

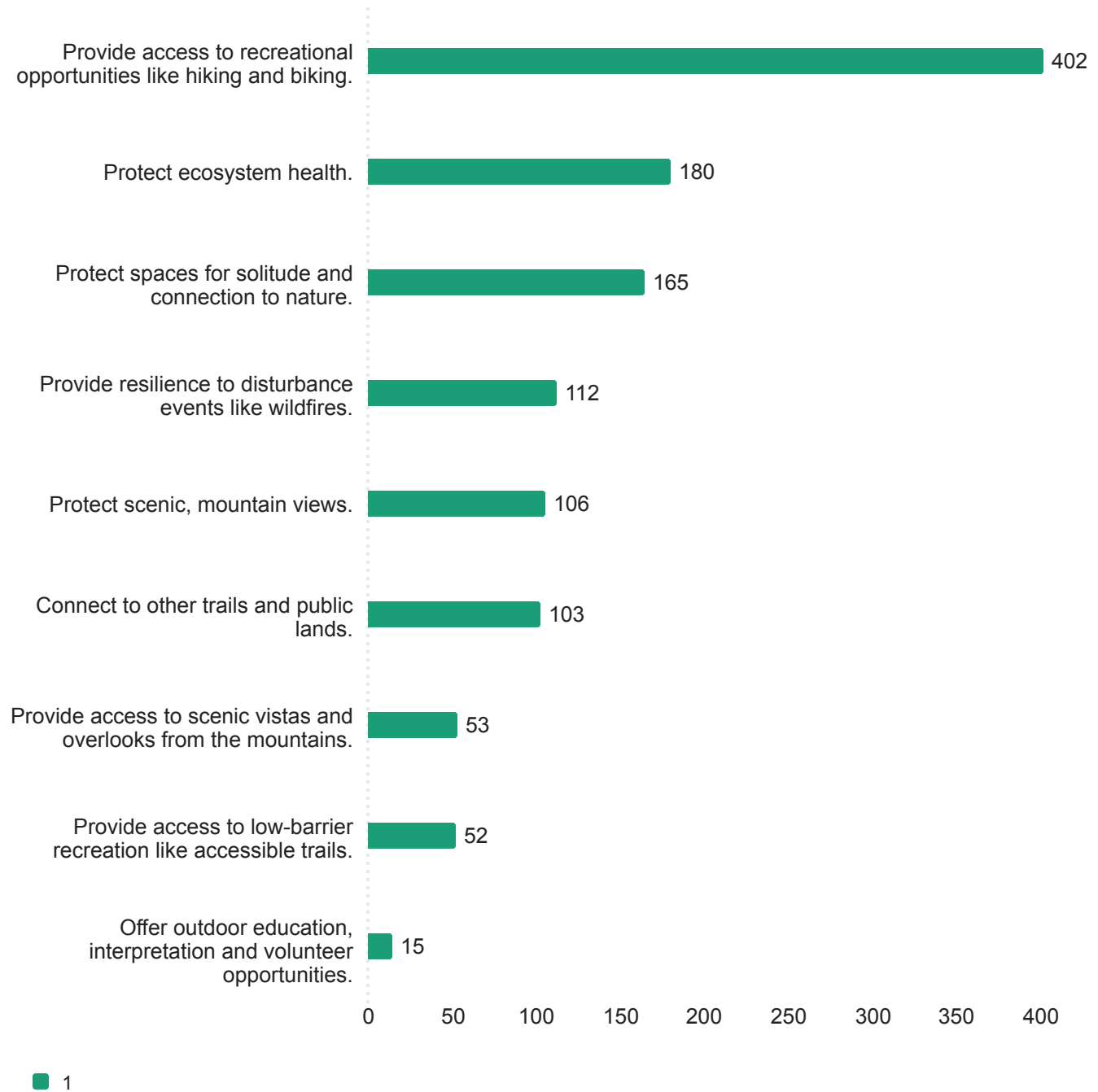
PROMOTION: The survey link was promoted through the City's social media platform, social media short videos, mention in a news article on the site, distribution to the focus group stakeholder contacts and on the City's webpage.

SURVEY DATA QUALITY: The survey platform utilized Qualtrics survey analytics. Qualtrics uses a quality response tracking system to identify potential bots, unanswered questions and repeat survey responses from same IP address (potential "ballot stuffing"). The overall survey had a 92% (excellent) response rating. The reCAPTCHA (bot detector) score is 1.0 for the survey instrument, which indicates a very good interaction with participants and low indication of bot or fraudulent survey responses.

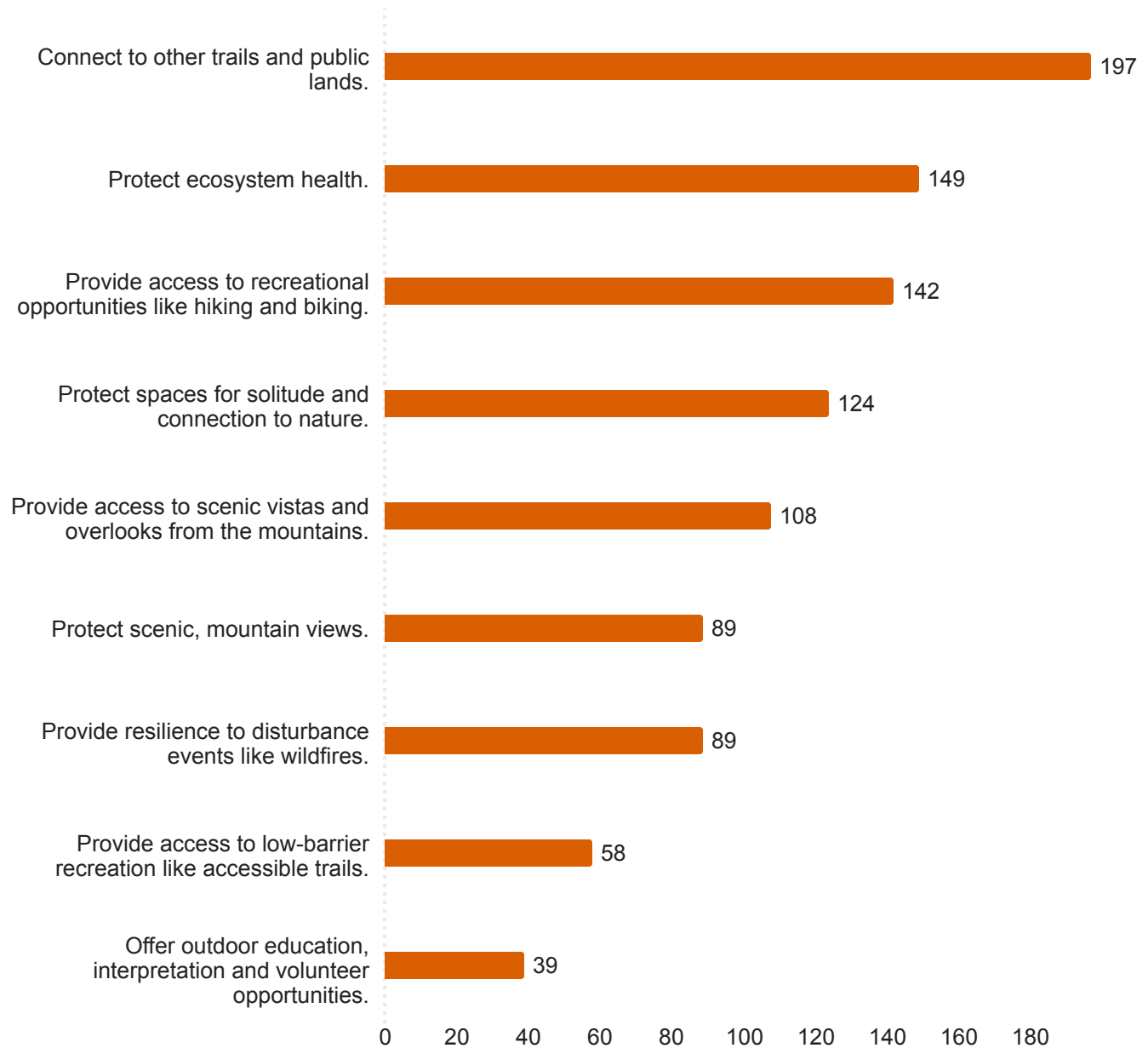

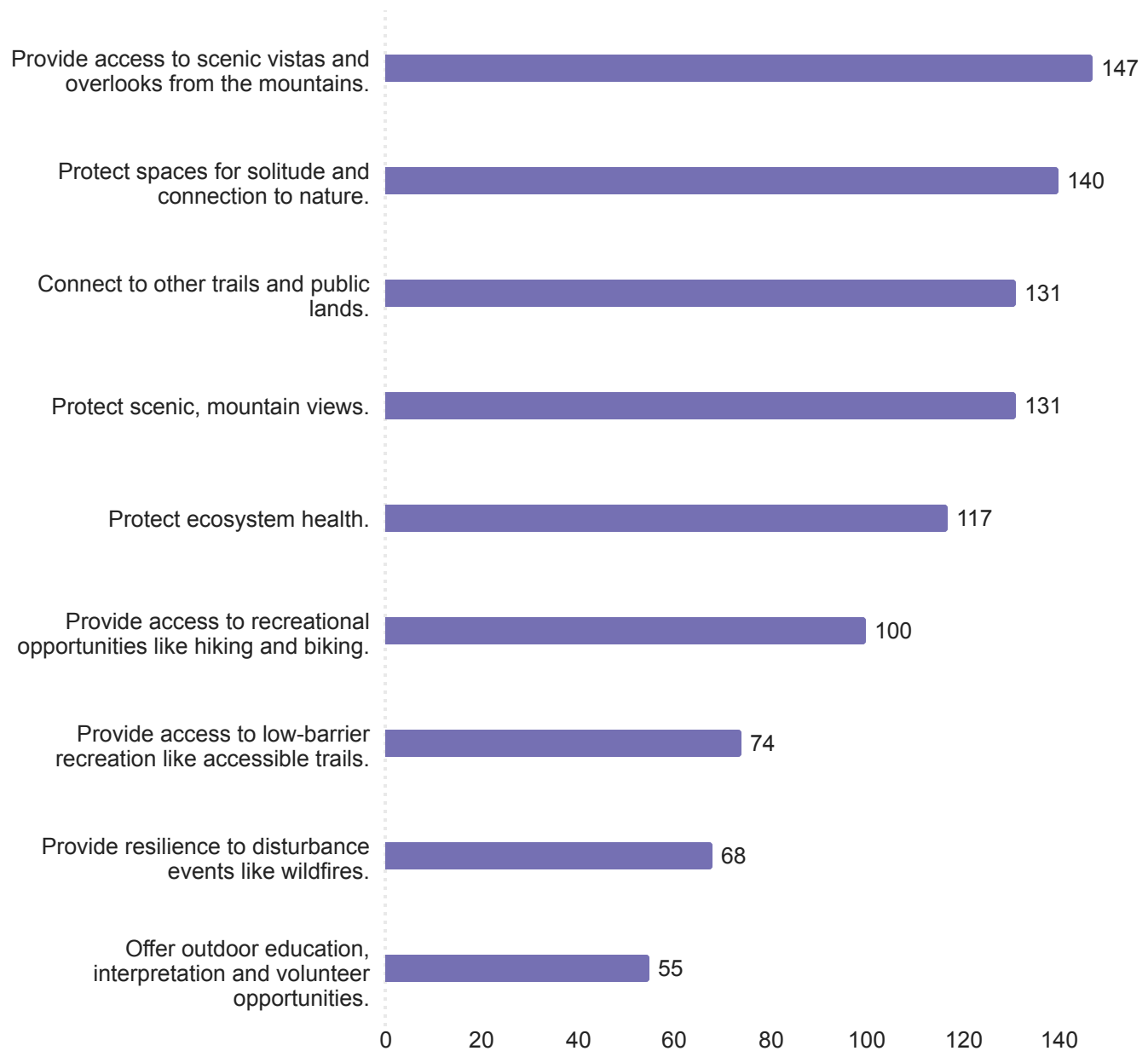

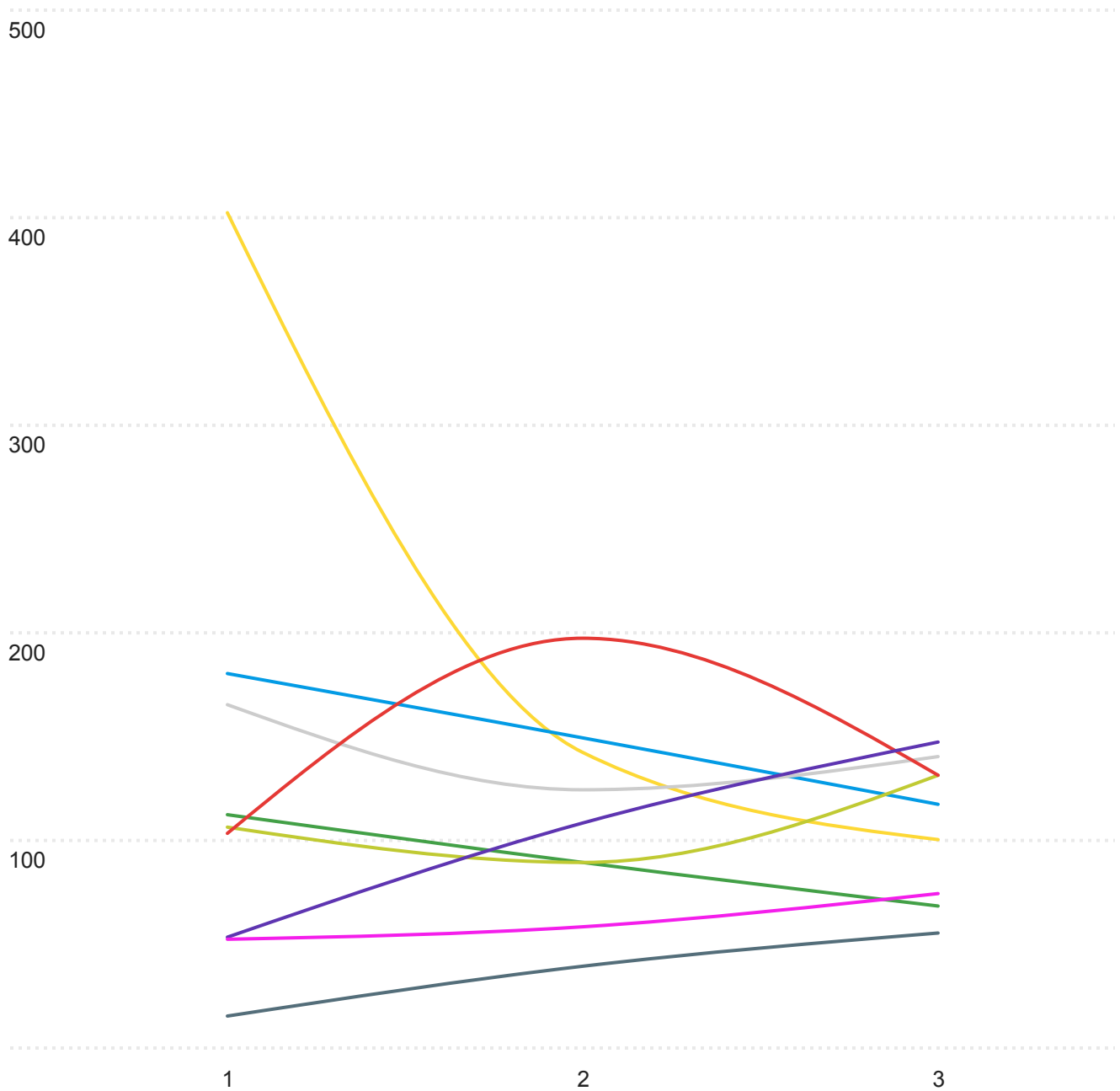

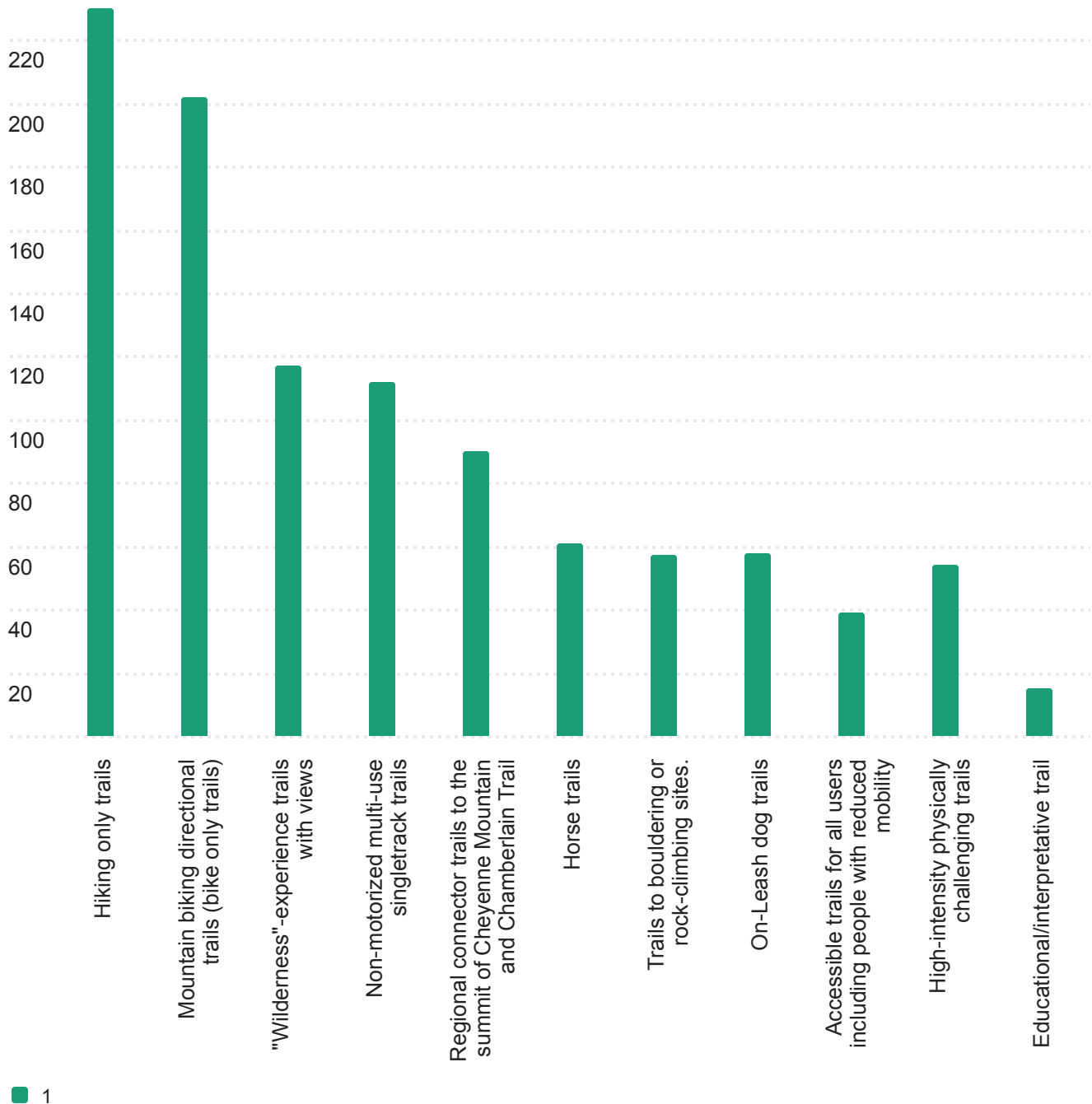

RESULTS FOR 1st CHOICE

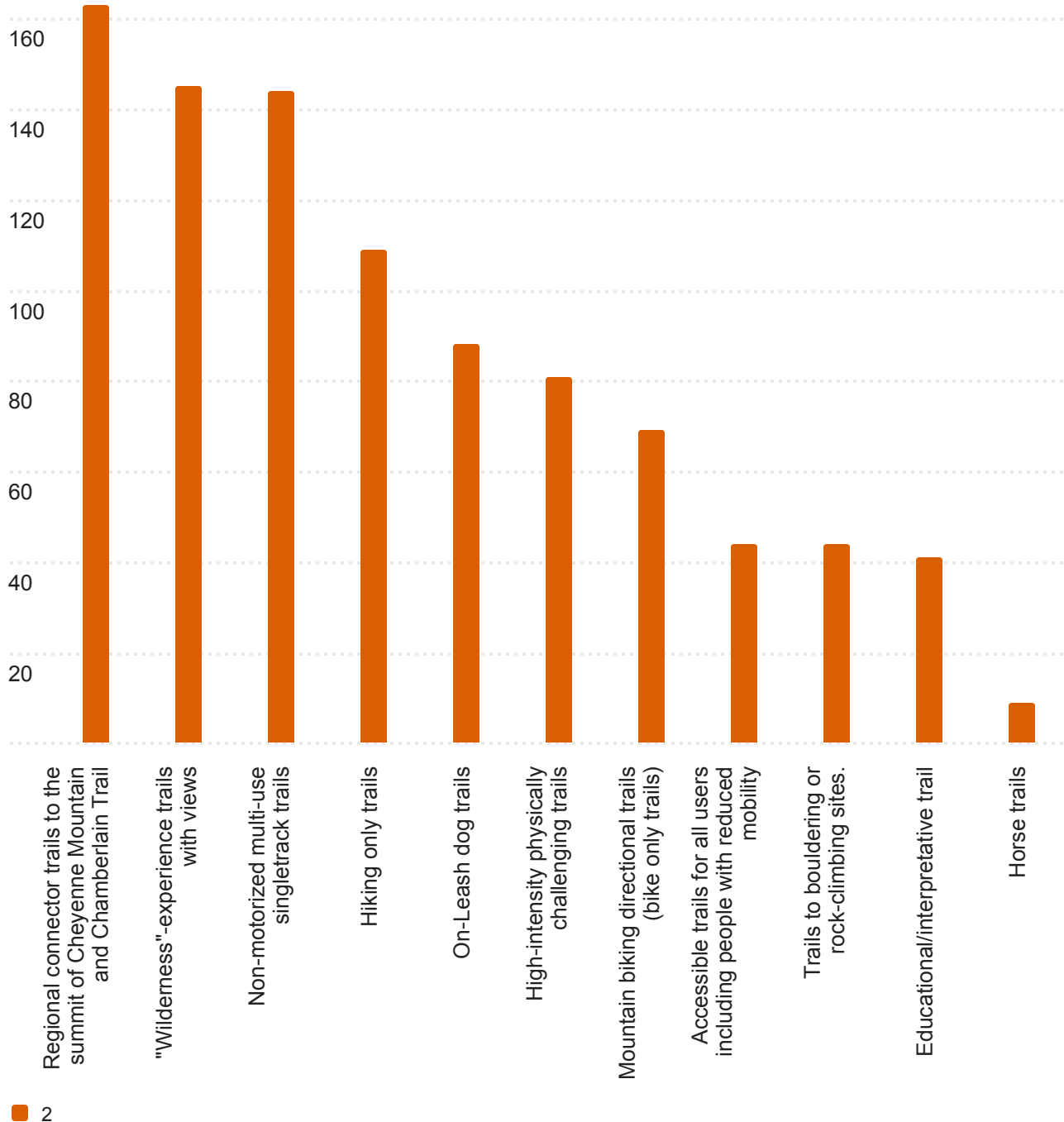

RESULTS FOR 2nd CHOICE

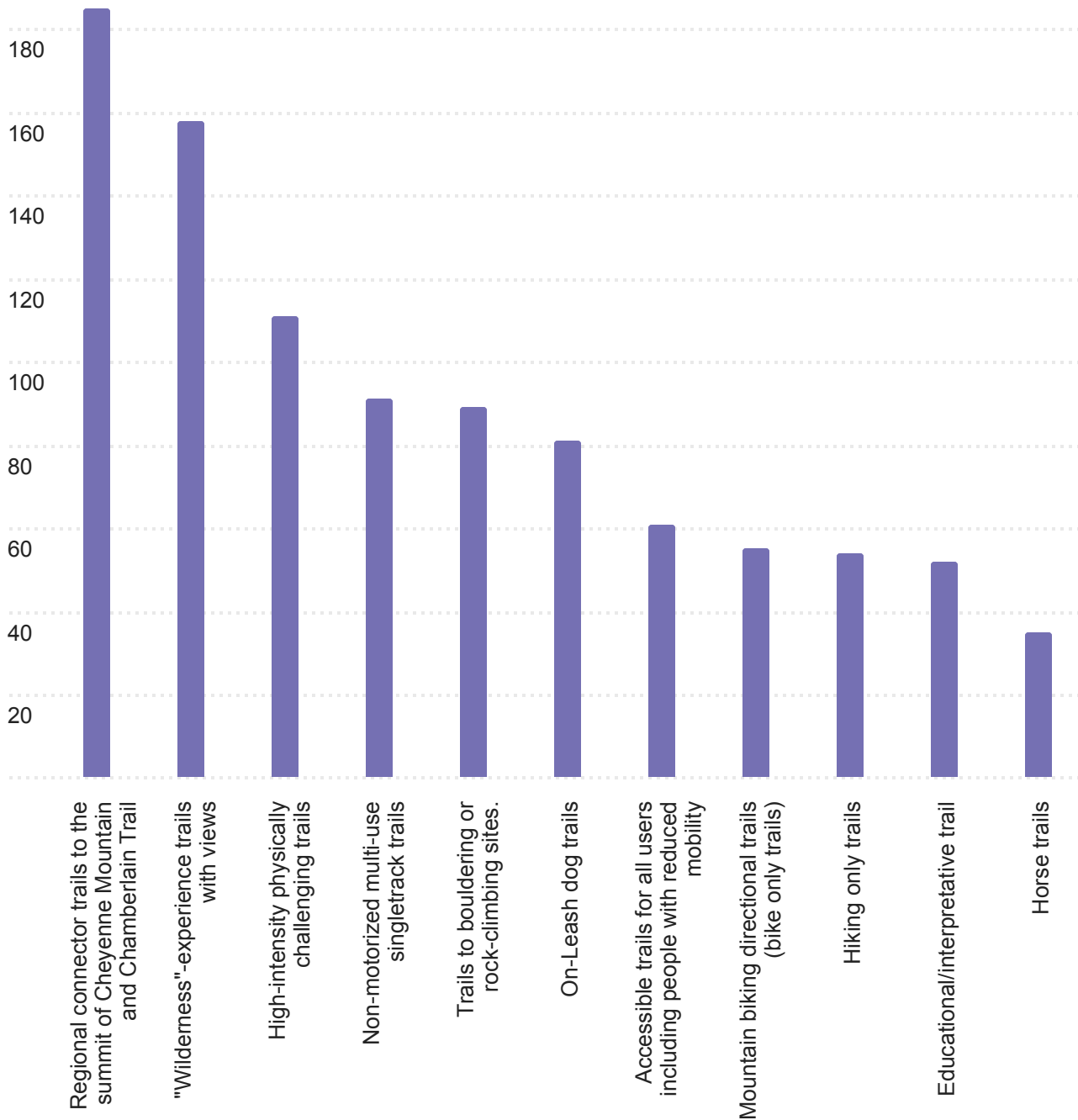

RESULTS FOR 3rd CHOICE

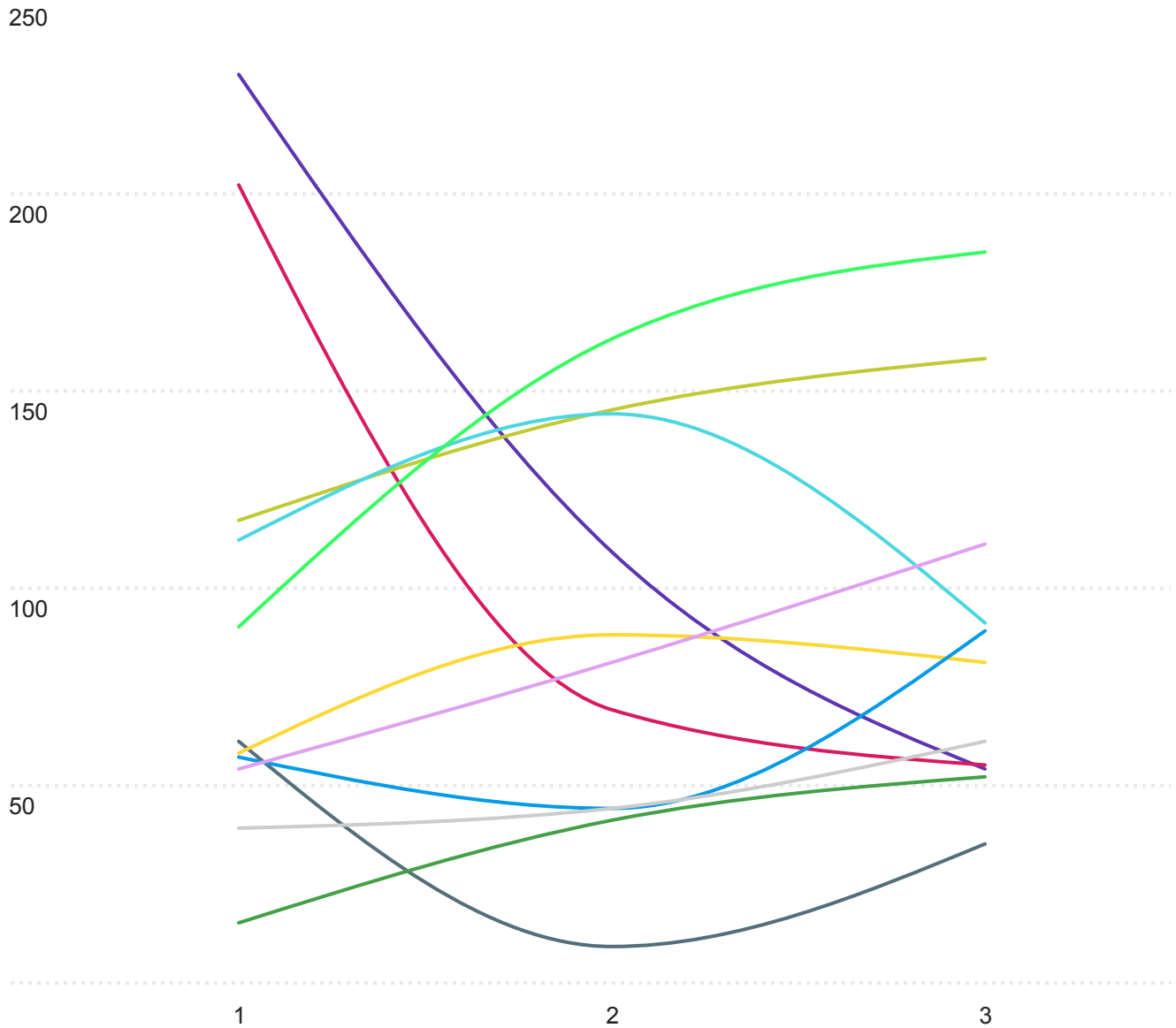

Enough trailhead parking to minimize redirected recreation traffic impact in local neighborhood from currently closed open spaces like Waldo Canyon or overflow not able to park at Red Rocks during peak hours

volunteer opportunities

Thank you for engaging in this project.

I am very concerned about traffic leading to the parking area through Broadmoor Bluffs and Spires neighborhood. I also have a great concern about increased trespassing and crime as this property is surrounded by private homes. Wildfire risk is also a huge concern.

Advanced level mountain bike trails need to be built in the Colorado Springs area to continue to promote a healthy outdoor activity that will also draw tourism to the area

Trails that are fun to ride bikes on! Green and blue trails don't have to be boring for experienced riders and can still be at a level where beginner trail users can benefit.

The terrain is a great opportunity to fill a big gap in local biking trail systems - steep and technical descents. This would be an exciting use for the space and help alleviate some issues with unsanctioned biking trails in other local open spaces

Ensure neighborhoods are not used for parking. Restrict hours. Restrict to no campfires. Restrict to no off leash. Ensure multiple access point with non-visible from neighborhood parking.

Birding Trail (No dogs or bikes), native plant ID signage

Thank you for preserving this space!

Active connections to Colorado College, UCCS, and local high schools, perhaps especially the Colorado Springs School, to provide educational resources, study sites, and interpretive trails, and a permanent register of the flora and fauna, available to the public.

Connecting to cheyenne mountain stat park and cheyenne canon would be amazing

No traffic through existing residential areas.

Please keep the trails 3-6 miles in length and have a parking area.

It would be interesting to have access to Old Stage road to transmitter lane. This would require coordination with the state park to access the road south the private transmitter property. (A trail into the national forest would be interesting as well, but as seen in the Blodgett OS planning would be for the far future.)

I also think the connection to the state park is important. Right now the only way to reach it (other than by car) is down HWY115, which has no pedestrian or cycling infrastructure. I could be wrong, but there does not appear to be any legal access along Norad Rd

While local residents may (will) complain about increased traffic, they do not own the roads and do not have exclusive use of open areas. The space should be accessible for the whole community. With that said, it probably should have minimal facilities. The space should probably be more of a local park and not a regional one like North Cheyenne Canon or Garden of the Gods.

Trail head safety is very important. Crimes are frequently trail heads. You are creating a walkway into a tender box of deadwood and fallen trees. Careful attention should be paid to have no camping and have Park Rangers or park ambassadors.

Is there any water on the property? Any chance to do hydropower? Any chance to do watershed education?

The one thing I like about Cheyenne Mountain State Park is that dogs are not supposed to be on the trails. I have dogs and use to take them hiking. Unfortunately, too many irresponsible people do not pick up after their dogs and do not obey the leash laws. I no longer hike public trails because of this, and I no longer take my dogs hiking due to too many incidents with off leash dogs. If you open this area, I recommend no dogs allowed especially since it is highly occupied by wildlife and close to the State Park.

Please focus for both hikers and mountain bikers

If conservation is the goal, please consider not allowing anything other than foot traffic. The area has such a unique ecosystem, native plants, pollinators, migratory bird nesting sites that are important to protect. So many people are living here now that don't understand the system of nature, I fear irreparable damage if you all don't take care to conserve the dwindling natural areas. Humans aren't the only ones who live here.

Adequate parking

Please, hiking trails only. There are a lot of mountain bike trails already. To often those on mountain bikes chose to make their own paths which cause erosion, disturb wildlife, tear up the land.

Protection of any historical artifacts in the canyon, such as the Fisher cabin site, The Eisenmenger cabin site, the Penrose pipeline.

Another incline?

Keep pushing (planning, media) so it can finally be on the front burner. Prepare to have rebuttals to the NIMBY's! Thanks for your efforts!

Thank you for this survey. Please work to preserve this beautiful natural area. Thank you!

If possible, hiking only & biking only trails

Ensure that future fire mitigation efforts do not negatively impact species such as Mexican spotted owls by creating uniform, homogenous forests that lack diverse habitat elements and spatial/size class diversity. Retain biological legacies, snags and coarse woody debris that provide habitat for the owl's prey species.

Old fat people like to hoke too without having to dodge speeding mountain bikers.

My preference would be trails that did NOT allow dogs, bikes and anything motorized except wheelchairs. if we are to keep wildlife in this area, all three of these things make it so much harder for them to thrive. Dogs, for instance, greatly disturb the wildlife, and tend to foul the environment. Motorized things frighten and drive away wildlife. Bikes are also frightening to the animals, and, frankly, they are a pain in the neck to walkers!

Portapotties at trailhead

Red rock open space has been completely too over engineered. You've ruined the nature with all of the WWI style barricades. Every view is obstructed by fencing and humans. It now looks so un natural. Do not do that to this park

Leaving forest detritus when designating trail to help minimize erosion.

We'd like some interconnected loops accessible to mountain bikes.

Ample parking is essential for public access.

This is a rugged, steep area, don't ruin it by trying to make it an area for everyone and everything.

Please leave this area alone. It seems the new better way always fails. If people can get to the points of interest, great. But no trails for anyone.

Downhill-only mountain bike trails that are challenging. There are a large amount of riders around here that have a strong desire for more of this

Not at this time

Connect up high, potentially to the summit and the Dixon trail

Multi Use trails.

While this most likely can't even be considered due to open space regulations, dirt bike single track access to the trails further back. This seems like a good spot to build connector trail to dirt bike trail system around Gold Camp and Mt Rosa and may help alleviate the traffic around lower Gold Camp and Captain Jacks trail. I understand the differences with motorized recreation and the limitations in place, just putting out the idea. Thank you for your work and considerations!

If I'm correct, this is the parcel of land the Broadmoor traded the city for the Strawberry Fields. That should have never happened. Regardless, this open space should now never be "traded" (sold). Open space is not a commodity- it's habitat for wildlife and plants and more which all support an ecosystem. As habitat continues to be modernized and often eliminated, it should be treated as our most valuable "resource." This swap was about the Chamberlain connection for small interest groups (unfortunately a mountain bike oriented group who chose to sell the very soil they tolls their wheels on). I'm a mountain biker, and I'm grateful and thankful for the places I can ride. Yet the most important thing is saving our open space and never ever allowing our city to "trade" any of it ever again

Jump trail for bikes

Since Cheyenne SP doesn't allow dogs on most trails, it would really be great to allow leashed dogs in Fishers Canyon. Looking forward to exploring new trails!

Steep, technical hiking and biking trails

Directional downhill mountain biking trail like the chutes

Establish chamberlain links as first priority

Hiking only and biking only trails. Rock climbing.

Expanding our opportunities for bikers would be wonderful. Colorado Springs is a mountain biking Mecca and we need to continue expanding trails for the increasing population. We want to keep businesses here that revolve around mountain biking, like SRAM and Rock Shocks providing opportunities for work, tourism, and outdoor recreation.

Protecting the private property surrounding and the surround private trail systems

Ensure neighboring communities are not impacted by increased traffic, noise and/or fire danger.

Yes, I live near the base of one the possible trail head heading into the Canyon. It is a quiet road with not much traffic and we would like to keep it that way. Please co-locate parking lots and larger trailhead accesses with existing higher traffic and parking areas in order to preserve the standard of living of the surrounding Broadmoor Bluff neighborhoods. Thanks.

parking - this is a yes in my backyard moment so I'm excited while sharing the concerns around parking and safety.

It would be great to see trail connections to both the Dixon Trail from CMSP and the MacNeil/Sunrise trails to The Horns.

Keep trails away from homes and drainage systems unless city wants to assume the maintenance

The planning team should consider what opportunities exist for facilitated access. Where the public may feel more comfortable using a guide. Things like rock climbing, outdoor education, or other nature programs would increase access with supervision that educates visitors. Working with organizations in advance will provide opportunities to create a system that benefits those involved.

Parking and facilities (garbage, porta potties)

When planning city resources for climbing and bouldering access, contact the PPCA. Working with them to help trail build or plan might save money and time.

No dogs allowed trail. Pet owners are irresponsible with poop bags if they even bother to Scoop their Poop.

Shared access to open space is key.

There is what appears to be a significant amount of rock in this area that would be an excellent expansion on the Colorado Springs area rock climbing offerings.

Rock climbing development with local guide services, specifically certified entities like: Pikes Peak Alpine School., US Air Force Academy & Colorado Climbing Cokoany.

Limit bike access - too many hiking trails are overrun by bikers using motorized bikes and/or not yielding to hikers

Trust that I want to protect the natural habitats and geology of the land, but as a mountain biker feel we need more trails to support what many are doing in other cities and states.

Picnic areas

Motorized vehicle (dirt bike) trails

I believe that this area should be left in its natural state, and that no trails, recreational area, public services should be added. There are plenty of recreational options throughout the city, and not all areas should be exploited. Let's keep this and other new areas under consideration, kept natural.

rock climbing

Look for ideal rock climbing walls. We need more in the city, and this will draw more visitors to our town

Forest fire danger to the surrounding homes

Wildfire risk, neighborhood traffic, parking, security, homeless camps, crime.

Maybe a small place for talks & presentations on topics like ecosystems, etc

Yes! Must consider and mitigate negative impacts (like crowds, traffic, trespassing, fire risks) to surrounding neighborhoods that have existed long before this new park. This is most important.

There are many opportunities for the planning team to show support for climbing and bouldering in this area. They should allow motivated community members (of which there will be very few) to use dispersed low impact off trail exploration and establish them in a style that is responsible. If development of quality climbing occurs and begins to gain popularity, then any plan created for park management should include provisions to support it along with further support of more established trails to it and recognition of climbers desire to use chalk, and other well established traditions of modern climbing.

Preservation over recreation. Please don't let this be another place where mountain bikers ruin the trails and make it miserable for people who just want a peaceful day hike like Ute Valley Park has been ruined. Leave vast areas alone for the wildlife. Don't make this all about people. That just adds up to encroachment.

Impact on wildlife living in the area.

Not sure what climbing opportunities exist in this area, but access to cliffs and allowing route development & bolting would be great. Also very excited to enjoy some new local hiking trails. Please prohibit off leash dogs and motorbikes.

Consider e-bikes for multi use trails.

Backpacking campsites

Please make sure private owned space near the park is protected from trespass. It is important the park focuses on the natural environment and highlights views and protects wild life. I would like to see hiking only trails. Parks like Stratton are mountain bike focused and maybe this park should be hiking focused. Connection to other parks is really not a priority for me.

Yes. Preserving the beauty and ecological functions of this area should be of paramount importance, and in direct contradiction to developing this space for public use.

This survey does not seem to be a sincere effort to determine the needs and wishes of the community.

Single use hiking trails in a quiet and serene natural environment is most important. There must be steps taken to prevent trespassing on private property.

Downhill bike trails!

Really interested in rock climbing in the area and excited for a 26mile trail that would be great

When the trail location encounters rock, don't chop the rock out, but instead allow for some natural technical challenges. If there is an opportunity to create an easy line and a hard line without cutting or blasting existing rock and boulders, go for it. Remember it took eons for that rock to be made, don't destroy it just because you can.

The more dog friendly, the better since Cheyenne Mountain State Park doesn't allow them.

Consider allowing backpack camping, not regular camping though. Backpackers are way more respectful than some of the disrespectful car campers. But there isn't any close backpacking. We are punished for the sins of others.

It feels like many of the trails added/ improved lately have been very bike focused. I mtb, but think the focus has not been balanced for hikers and trail runners.

Connection and access to Cheyenne Mountain State Park via biking or hiking.

I think the altitude and terrain across Cheyenne Mountain will make this cost prohibitive and a bad investment for taxpayers

Access to rock climbing and bouldering is very important to me. Thank you!

When developing open spaces, ADA and accessible trails should ALWAYS be included. It doesn't have to be every trail, but there should also be significant access for people with disabilities.

Keep designing these awesome open spaces!

I am opposed to this trail.

It would be great to have separate bike and hike trails that go to similar places so groups do not feel left out and the speed difference between bikes and hikers is less of an issue.

Prefer the area to be dog-free.

So excited for this space to be available!

I would love for you visionary planners to realize that area has people living there, many own larger properties that you're looking to destroy in the name of "recreation and tourism ". You've neglected to include the people living right here in your "vision". I think you need to be in discussion with SW Hwy 115 fire protection district. Everyone living in this corridor is nervous about idiots in the forest starting a fire that will destroy our property. You're inviting thousands of people into our back yards with no real idea about what the mega drought has done to the ecosystem. I see a future problem with erosion, can the city afford the expense to repair more damaged trails? What you see as a playground, I see (as a resident of Rock Creek Mesa) a habitat, an ecosystem that is really out of balance. I have a creek on my property that dried up 5 years ago, causing distress to the wildlife habitat, I'm watching erosion and the death of flora because of the drought conditions that persist. Inviting the entire city and tourists to play in this area is not a way to conserve the ecosystem. It's disturbing that you all are so disconnected from nature. My family is absolutely against this long range plan to further destroy our ecosystem.

It would be nice if we could keep foot trails and mountain biking trails separate.

Please consider the impacts on neighborhoods, especially in areas where trailheads are not established. I look forward to the connection with the Chamberlain Trail.

Camping for multi day bike packing

Make difficult biking trails. Black rated and above. Biking trails without cool and challenging features are not desirable.

Please be considerate of the adjacent neighborhood, as many of us have chosen to live in this area because of the remoteness and quiet surroundings. We are not interested in creating a playground in our backyard.

Consider no dog areas. They tend to scare off wildlife and often times make hiking less enjoyable with their noise and, the unfortunate, bad owner who doesn't clean up.

I would like to see some hiking only trails to take my dog on. It's hard with people on mtn bikes never slowing down. Realistically trails for all users would be the best option for the space.

Let a mtn bike trail group assist

A trail hub center that will facilitate shuttles and services for Chamberlain Trail thru-travel.

A nature playground, informal picnic sites (similar to south canyon in NCC), and family friendly trail loops in the lower flat(ish) area.

Challenging downhill and directional mountain bike trails.

Care in limiting access to gated communities

Ample parking

No I live in the neighborhood below and I don't want this space open to the public

Access. Broadmore will have a HISSY fit if we park in their neighborhoods even though they park in ours for access to trails and parks.

Please allow dogs. Pretty please

Please consider allowing up to 2 events per year use this awesome trail connection to make a long distance endurance event (trail running or mountain biking)

Connect the existing trail around the West side of Cheyenne Mountain coming from Old Stage Rd by the riding stables. I think most of the west end is too steep for bikes to share trails.

Directional mtb trails

Rowdy and steep MTB only downhill trail (at least one).

No bikes or mountain bikes... sorry these riders are often very rude and self important... I myself have nearly been ran over and ran off the path way and fallen into the ditch...

Access to the trails / open space not impacting broadmoor bluffs neighborhood area negatively

Real stoked for this new open space and what may come of it!

Don't make the same mistakes made at places like Pulpit Rock. Ensure trails are well-marked before opening to the public.

Designated parking spaces that don't disrupt neighborhoods. Also enough spaces available so parking does not flow onto neighborhood streets like by Stratton Open Space. There is not enough parking spaces there.

A Forest school for the local school district.

Off-leash dog hike

Connections to the USFS area and or trails. Wild fire mitigation work within the Fishers Canyon OS.

Access to hunting in the adjacent national forest.

Rock climbing, and steep sustainable hiking paths

I would personally like an archery range in this area but understand the limitations and hesitancy to make one.

Accessibility and entrance points

Ensuring trail space mitigates impact to residential homes, are fire wise and not used for homeless encroachment - but allow for access and connection to existing trails

multi-use connection trails

Please protect the nearby neighborhoods from fire and consider parking access that is respectful to the residents.

Multi use access trails that split in to bike only directional trails, hike only and mixed use, + climber only access trails to the rock faces and rock tops. Bonus points for some winter cross-country or snowshoe paths.

Enough parking

Access for rock climbing and climbing development!

Good signage and bathrooms

Fire prevention, drainage and water mitigation, take-on ownership of Spires HOA drainage areas within the Fisher's canyon open space, prevent vagrancy and overnight camping, address the risk that open space might invite crime to the Spires and Broadmoor-area neighborhoods. Address risk of parking for open space on Irvington Court, Wellfleet, and Ellsworth streets in front of houses and how that will impact the neighborhoods. Prevent off-leash dogs. Mandate cleaning up after dogs.

Connect trails into a large loop if CMSP could be connected to Old Stage with connection to pipeline and/or Ring the Peak. Adding deep access only overnight camping would be great. Bike packers could take 26 mile trail Chamberline plus another XX miles around Rosa and Almagre and down pipeline, Jacks and Stratton to create a long loop with an overnight option.

To maintain the serenity, hygiene, and sustainability of the environment for both humans and wildlife prohibit dogs on the trail system. As examples by most of our parks, many dog owners are incapable of leashing or cleaning up after their pets. It would be easier to enforce a no-dogs policy.

Additionally, no e-bikes should be allowed. As examples by red rock open space, people are using no peddle electric powered bicycles. These are basically electric motorcycles and travel much faster both up and down mountain trails.

Ample parking space that can accommodate expected number of visitors during peak season, so there is less risk of encroaching on private property

Please install a parking lot at the main trailhead. Interpretive signs would be great, as would historical markers about NORAD and the Fisher and Star homestead and ranches.

Be aware that proposed trails run very near residential communities. We do not wish the negative aspects of trail use: diversion to & thru our community; dangers from careless smoking; prying eyes scoping homes out to possible buy rob (vagrants have already been a problem on Old Mtn Course)...

Wild fire mitigation

The list on the previous page covered about all that you can do. Specifically at least 1 down hill mtb only trail would be nice. Also a high intensity hiking only trail would be nice - I think there could be an opportunity for something similar to the incline. Lastly, I think a beginner/moderate hiking only trail would be nice for older people and families to enjoy and not have to worry about bike riders.

Allow dogs everywhere please!

I am very excited about new open space. I feel like this open space should stay relatively closed off to the public and left for the wildlife. We have so many hiking/biking/educational parks next to this open space that get tons of visitors and use it would be nice to let "Nature" have a small patch with little human impact. I think as a Native to Colorado Springs all of our parks are really busy and there is no place left to get out and have some peace with out people and interpretative trails etc. It would be nice to have a some more of the beaten track trails that you need to seek out again. Not everything has to be a top tourist destination we already have that with Garden of the Gods (which I live right by and never visit because it is too busy). Maybe keeping some space for wildlife and "wild people" would be great. I miss the good old days when you could go hiking and not see too many people...not all roads need to be paved.

Create enough parking

Thank you for considering the rock climbing community!

There are great climbing opportunities! Please please please please please reach out to the Pikes Peak Climbing Coalition and discuss bolting, ethics, and access.

Please allow rock climbing access including bolted sport routes and bouldering!

areas for cultivating native flowers/plants for pollinator support; possible assistance from local groups or individuals

Sport climbing in the local Colorado Springs area is lacking compared to Denver, Boulder, or Fort Collins. Cheyenne Canyon has very poor rock quality and red rock open space and Garden of the gods are very dangerous and "runout" for newer climbers. I hope climbing in Fischer canyon can be developed sustainably and become a prime place for locals and others to enjoy.

CS has a large number of veterans with both physical and mental trauma. They need intense activities to help them cope. We need trails that replace the adrenaline of the battlefield. It wouldn't hurt to have an area with trails named after military units or acronyms to honor their service. This area is perfectly located near Fort Carson, too.

Trailhead parking.

Small hike-in access trail heads for the surrounding neighborhoods I.e Star Ranch gated community

Bike trails do not need to be wide or bike only. Leave them technical with lots of elevation, and naturally most beginner riders will not ride there. I understand there is community push back for the bike trails. Single track is fine, but no need in my opinion to make it wide or bike specific.

- 2) The accumulation of trash and dog poop bags detract from the nature experience. There should be bear resistant trash cans at every trailhead and fees for littering or leaving dog poop behind. You could also get local youth groups or volunteers to pick up dog poop twice a year.
- 3) The high volume of people living and recreating in Colorado Springs requires more rules to prevent miscommunications on trails. Mountain bikers should have set directions on certain days for going downhill. There should be "pull out lanes" for fast people to pass slow people or allow hikers to step aside for bikers. There should be employees at parking lots on summer weekends to prevent fights and help direct the flow of traffic.

Secure emergency evacuation and access routes. Control possible loitering, and garbage pickup. How about building fences to prevent trespassing on neighboring communities? Build no picnic areas. Yes, as a planning team stop all your planning activities for Fishers Canyon Open Space! Let this area untouched, we don't need more recreational activities on the South West side from town. There's already plenty of opportunities for recreation at this side of town. We don't need even more risk for wildfires and criminal activities. PLEASE LEAVE NATURE UNTOUCHED!!

As a resident of the Broadmoor Resort community, I am opposed to opening Fishers Canyon to the public.

I am a resident of the Broadmoor Resort Community and my family and neighbors are extremely worried about these trails affecting increased wildfire risk, trespassing, and potential crime in our neighborhood. We've had 3 burglaries in our community within the past year, and 2 already within the past few months. This happened despite having gates and security guards on duty 24/7. Having trails parallel to and immediately adjacent to our property boundary is very alarming. The Broadmoor Resort Community is already in a very high risk wildfire area, despite the fire mitigation efforts we have done. Our community would be destroyed very quickly in the event of a fire, and we adamantly oppose any plans that increase this risk. Additionally, new trails adjacent to our property boundary create a high risk security breach to our neighborhood.

Security for surrounding neighborhoods - keep access points well away from residential areas; prevent and actively police street parking; do not allow camping or fires; do not allow smoking; actively police for violations of private property and dogs off-leash. Off-leash dogs are frequently seen in open space areas -this significantly disturbs animals in an area that had previously been very safe for them, nesting, etc. Introducing cars and people is not a good idea at all!

Just leave it undisturbed! Cheyenne Mtn State Park is right there and is underutilized - why not encourage people to use that which already exists?

I strongly oppose this project.

My wife and I purchased a lot in the Broadmoor Resort Community and plan to build a home on it in the near future. One of the main attractions of the BRC is its security. There is no barrier between this new proposed public area and the BRC. Our lot is located at the west (top) of the community, with no protective fencing in existence or even allowed by law, as a large portion of our lot is in a protected Preservation Area. Consequently, there is open access to our home by anyone on foot, and we are legally prohibited from erecting protective fencing to prevent such access.

This new project would allow literally anyone to access our property, and there is no way I can prevent it. Worse, given our lot's location, it would take police a significant amount of time to reach our home, assuming we had time to make a call during an emergency.

While most hikers would be law abiding people with honorable intentions, some would not be. By opening up this area we are giving those with bad intentions easy, unrestricted access to our property and homes. Further, the fire danger in this already fire sensitive area would increase dramatically, as hikers--even those with good intentions--will create fire hazards. And, as with police protection, given the remote setting, it would take a long time for emergency personnel to arrive on site. The resulting damage to our homes and to the pristine Preservation Area and wildlife could be devastating.

I am pleading with you not to allow this project to move forward. The potential adverse and life-changing consequences far outweigh the benefits.

As a long time resident of the community adjacent to this parcel of land, I am opposed to this being developed because it will significantly increase wildfire risk, trespassing and crime to our residential neighborhood. There is no way to complete the chamberlain trail unless you go on the near vertical east facing part of cheyenne mountain. My community will vigorously oppose any suggestion that the chamberlain trail go through our neighborhood. We do not want the traffic on our private property nor the increase in wildfire risk. It is already difficult to get insurance for our homes due to existing risk and this will only increase the risk and the costs.

My concern about this space is that it could attract more foot traffic and compromise the perimeter security of the adjacent Broadmoor Resort Community. This MUST be considered as the development progresses.

A "use" fee. A base of tax dollars spent to provide necessary infrastructure makes the park safe and accessible for a wide (sometimes disparate) group of users. It addresses ADA, Wildfire, ecological, etc issues. But a Use Fee gets assessed for helping to underwrite on-going maintenance issues.

Make some of the trails rugged and challenging. There are plenty of open spaces that already provide easy and accessible trails, as well as plenty of flowing switchback trails for bikes. Not everyone wants easy trails!

Fire prevention. The last time the Cheyenne Mountain complex burned was over 50 years ago and resulted in loss of life. Since then the mountain has become a tinderbox of overgrowth. While I applaud the efforts of the city to perform the recent fire mitigation, any efforts to provide access must take the closeby neighborhoods' fire danger into consideration. No fires, smoking or spark producing activities can be allowed. Since the city refuses to conduct evacuation modeling, it is imperative that the TOPS group craft policies to prevent a need for an evacuation. Perhaps even closing the area on red flag days or in periods of extreme drought.

I am a resident of the Broadmoor Resort Community and would be concerned if connecting trails that are part of the Fisher Canyon Open Space project would negatively impact privacy and safety of our community. The roads and facilities in our community are not geared to accommodate large number of hikers, offers no restroom facilities (nor would our community want them) and concerns about how close public trails might come to private property and how keeping hikers, cyclists and others off private property would be enforced.

Please consider the amount of traffic both car and by foot this will bring into the community. We are already experiencing a rise in home burglaries, car break ins, theft, mailbox tampering, please don't bring more of that into our community. If we had known this was the plan for that land, we never would have bought here.

Signage with a scientific narrative of how the fuels mitigation treatments were developed and implemented including why there are much fewer trees now than when the treatments began. This narrative might include something call the "historic range of variability", in forest restoration management.

Please consider the increase in trespassing and opening our community up to crime, illegal camping, litter, forest fires, and endangerment of the animals that currently live in this area. The BRC opposes this trail system, we do not want people damaging the private trails we pay hundreds of dollars (per house) with our HOA dues to protect and maintain. Placing our community at risk of fire danger and crime when our police staffing is already low and could never get to us in time to help prevent any home burglary is concerning to our residents. Strategic, sustainably constructed recreation trails will reduce the temptation for users to create their own experiences and will enhance the conservation values of this unique property, which will have high visitation interest due to its location.

I am against the proposal

As a resident of the Spires neighborhood I am very concerned about how the additional traffic and lack of parking may negatively impact our neighborhood. My hope is that the planning team will insure that adequate parking will be made available within the Fishers Canyon Open Space in order to mitigate the impact to our neighborhood streets.

It would hugely increase fire danger and allow access to an unfenced area to the south of our community. Any trails proposed need to be far enough away from our property that access would be difficult to impossible to allow anyone to deviate through our community. I fear that ease of access for construction would make it probable the trail system would be right next to our private trail system and compromise our seclusion.

Yes. What are the plans for parking and the increased traffic in the Spires neighborhood?

Volunteer opportunities, e.g. removing invasive species or monitoring wildlife.

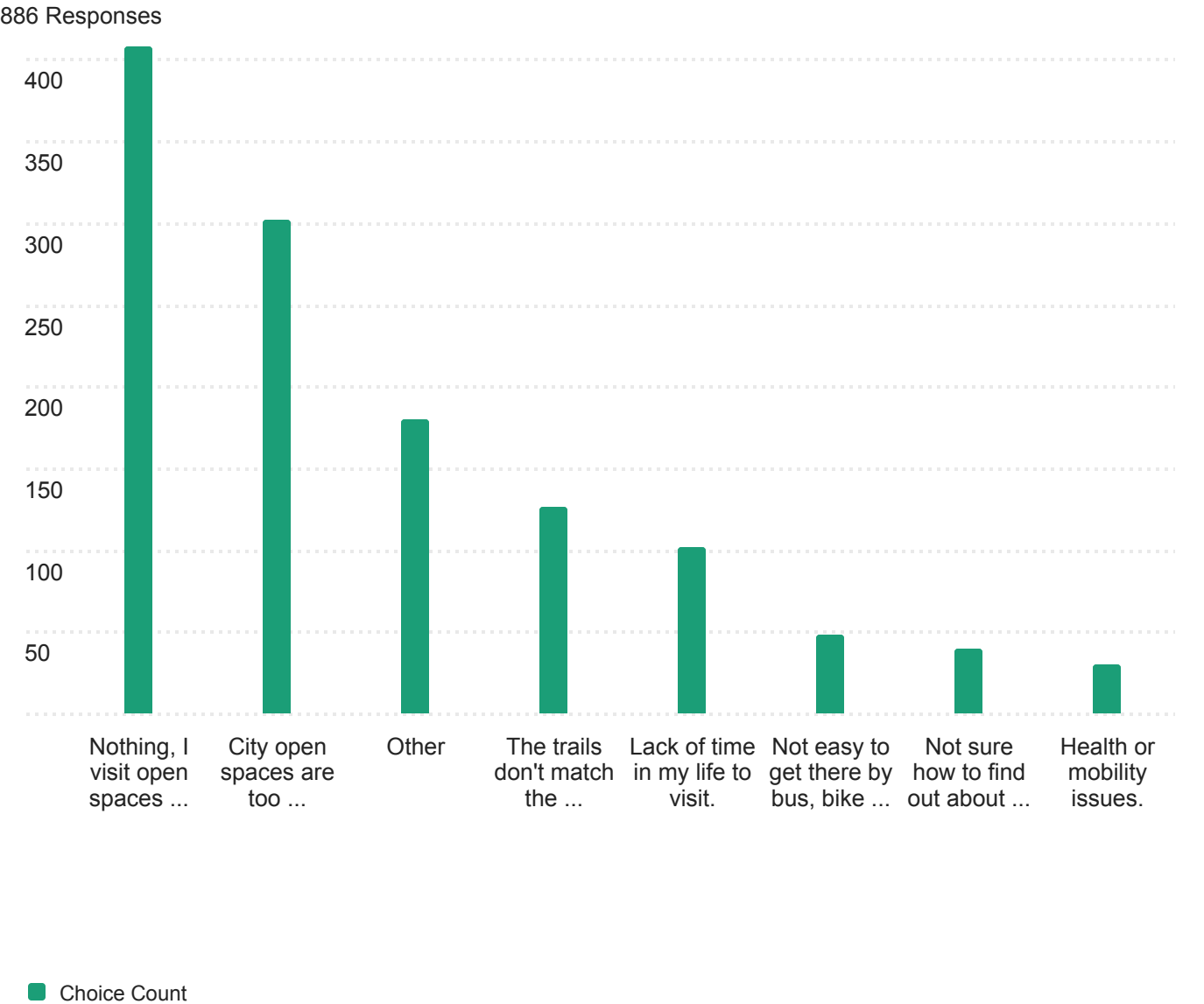
Fire prevention. The last time the Cheyenne Mountain complex burned was over 50 years ago and resulted in loss of life. Since then the mountain has become a tinderbox of overgrowth. While I applaud the efforts of the city to perform the recent fire mitigation, any efforts to provide access must take the closeby neighborhoods' fire danger into consideration. No fires, smoking or spark producing activities can be allowed. Since the city refuses to conduct evacuation modeling, it is imperative that the TOPS group craft policies to prevent a need for an evacuation. Perhaps even closing the area on red flag days or in periods of extreme drought.

Make some of the trails rugged and challenging. There are plenty of open spaces that already provide easy and accessible trails, as well as plenty of flowing switchback trails for bikes. Not everyone wants easy trails!

A "use" fee. A base of tax dollars spent to provide necessary infrastructure makes the park safe and accessible for a wide (sometimes disparate) group of users. It addresses ADA, Wildfire, ecological, etc issues. But a Use Fee gets assessed for helping to underwrite on-going maintenance issues.

Ready access by emergency vehicles to any point on a proposed use should be included on any plan.

Opposed to infrastructure that will negatively impact adjacent property in Spires HOA- noise pollution, congestion from vehicles, wind blown trash from visitors that attracts rodents and other undesirable animals, lowered property values, vandalism from visitors, unauthorized parking on nearby streets when parking lot is full, high increase in fire potential, run-off from trail erosion. For those people who live nearby nothing good will happen for adjacent homeowners when this canyon is developed.

Encroachment of people on our private land!

Security needs to be addressed from PRIVATE adjacent property!

Trails in Colorado are often crowded and overused, leading to both reduced enjoyment of "nature" and also leading to wildlife displacement.

Ethical concerns that I'm intruding on land that wild animals need. Humans keep encroaching on what's left—that's a bit selfish. No wonder there are more animal-human encounters. The animals always get the short end of the stick.

This property should be left as is in it's natural state and not open to the public.

I won't visit areas that have to be accessed through neighborhoods - I don't feel that is appropriate behavior and presents unfair stress on the people living in the area. I would prefer that access be limited to a public location - even if that mean a long hike to get to this new open space. Be considerate.

We visit those that are good for running, biking or rock climbing.

People who disrespect the open spaces and do not follow the rules

Too many tourists/visitors. People camping/drinking alcohol/illicit drug use! Please do NOT build a parking lot!!!

dogs not on leashes; vandals in parking areas.

Keep things natural; Not man made!

We walk all the time, but only in SAFE places. Need to have Rangers available to remove vagrants and panhandlers from those areas.

too difficult a trail and dangerous. we do not need this trail

However. If the trails are designed for bikers this will keep me away as it means I have to be wary of bikers coming up in me at fast speed at all times.

Not enough parking.

Too many cyclists

Too many bikes who don't slow down for hikers or realize they don't have the right-of-way.

More, and LONGER hiking only trails are needed IMO!

Off leash dogs

Abuse of the area by visitors (graffiti, dog poop, dogs off-leash, erosion caused by misuse of trails, mountain bikes).

I am not in favor of opening up the possibilities to unwanted intrusions like theft and increase the risk of fire in the area around us. This would be expensive for our neighborhood to handle and adds extra burdens that are not needed.

I do not wish to visit this area since I strongly oppose any further development of this land for any type of recreation. Or development.

This is a unique area that provides protection for the thousands of residents that live below the craggy rough slopes of granite as Deitemeyer points out the house size boulder. It is a buffer between humans and the animals and inhabited the natural environment. To introduce the chance of wildlife and homeless camps to this area isn't a very appealing situation to many of us who've worked all are lives to live on such a serene area of Colorado.

I tend not to visit open spaces that allow bikes and horses on most or all of the trails. These activities result in a poorer hiking experience, also seeing less wildlife.

Bike optimized trails are awful for hiking and trail running. The new trails in Red Rock Canyon Open Space, for example, were created with bikes in mind despite them supposedly being multi-use. The ability to enjoy those trails now as a hiker/trail runner have been severely compromised. Consequently, I do not visit RRCOS anymore and it used to be a place I visited weekly.

I will not visit this parcel because the city has destroyed it by clear cutting the trees and destroying wildlife habitat. It is a disgrace. The company who the city hired didn't properly manage the thinning. They literally went in and clear cut this parcel.

I don't want to disturb wildlife

There are plenty of parks around to visit, although some are dangerous for breaking into cars. My family visits the Cheyenne Mountain Park for a few picnics or races, Bear Creek Park for racquet plays, existing trails for biking. There is no need to create a new, unpopular one. It's maintenance cost is additional to the cost of building this Flisher Canyon connection.

Primarily interested in rock climbing, but would hike all the trails to be able to see it all at least once if nothing else.

I used to visit open spaces in the city often, but they are always overrun with visitors, a lot form out of state. SO we now have to drive out of the city if we want to hike and bike with some peace.

I often visit Stratton and Red Rock Canyon OSs but since I am a bike rider I try my best to visit at lower trafficked times- mainly evenings. Weekend mornings are brutal but I wouldn't recommend expanding parking lots. I think it's nice to cap the crowd.

I live next to Red Rock Open space and am thankful that our city offers these areas. Thank you City of Colorado Springs. You are wonderful.

Impact private housing - must have fencing

Lack of connectivity to adjacent trail systems--343 ac by itself will not have enough trail to justify the trip.

Regarding the crowded/parking comment above; crowding is rarely an issue in C/S and unlikely to be significant at Fisher's Canyon. If I cannot find a parking space after driving down there, that will encourage me to "make" one in a neighborhood or inappropriate place.

To many mountain bikes for my liking.

Too many dogs off leash (and too many poop bags); Unmaintained or overgrown trails; Too crowded or loud/disrespectful users (don't pack out trash, listening to music without headphones, broken bottles littering trails).

If the trails are like the machine built things that went in at Red Rocks, it's not worth it. Boring and poorly designed for bikes.

If dogs can't go we can't go

Some trails tend to have litter and dog poop. I hope people respect this new open space unlike some others.

We use all the West Open Spaces daily and biggest deterrents are: Large Tourist tour groups (the Broadmoor bike tours in Stratton and the Jeeps above on Gold Camp), off leash dogs and their unfriendly owners (literally every open space but Stratton tends to be the worst due to the water).

Weather is a huge factor. In the summer, looking for shaded trails, in the winter looking for trails that have a lot of sun to dry up the muddy ground

Trails that are not fun and challenging on a bike

The wildfire danger is extreme in the area you're promoting. It's putting residents and wildlife in danger. Did you know that we have at least 1 fire in the forest here every year? I'm fearful that exposing this area to ignorant people "playing" will put my property and pets in danger. You're plans will fundamentally change my neighborhood in a negative way by bringing trespassing, with no law enforcement (the way they are currently), more traffic to an area currently immune from the greater public (which is why we live out here). The changes you're forcing on people who live in the rural areas of the county really aren't positive for anyone but you folks working in an office. I personally hate what's going on here, you're ruining everything that makes the front range unique all so that a small portion of the population can ride a bike in the woods.

Too many dogs there especially off-leash

I have heard that because of the terrain, the expense will be great and I am opposed to spending TOPS money to complete this connecting trail.

Don't increase parking at open spaces, create more open spaces. Increasing parking wastes otherwise natural space and creates overuse. If increased access is necessary, do not expand parking. Make it accessible by bike, walking, and public transit. Everyone should be close enough to an open space that driving isn't necessary.

parking can be an issue

I still visit often and the fact that these places can be crowded at times just indicates how important they are.

Homeless camps, crime, littering, drugs, Fisher Canyon potential fire danger is very high, wild animals coming down from Cheyenne Mtn for food, endangering the wildlife with food that are not part of their habitat, horrible graffiti on Cheyenne Mountain as on Old Stage Road, people endangering the very close nearby communities.

Crowds and traffic noise. Noise from planes.

I hike and would like to see more hiking trails and less multi-use trails.

Dogs that might be off leash or not controlled by owners

Many parks are fast becoming landscapes of fences, signposts, and destructive trail and "maintenance" projects. More parking increases visitors and parking should be a natural limiter rather than increasing excessive development to manage crowds. Climbing has come under attack in our city which could pride itself on the rich history of bouldering and rope climbs it has like the city of Boulder does. Unfortunately, the city instead has followed agendas to remove the use of chalk (accepted in almost all other places in US and world, safer, and used for over 70 years to elevate climbing to its modern state). Climbing is now an olympic sport and world class outdoor climbing should be whole heartedly supported in Olympic city usa.

I use them mostly in my dog walking, but would like to see more Mountain bike down tech (blue and green) trails offered.

Biking - too few hiking only trails and bikers riding too fast (and often on motorized bikes where it is not legal) and not yielding to hikers. Motorized bikes are making it so bikers can be a danger to hikers even when bikes are traveling uphill on trails.

Too many people. I can see people anywhere in this city. I go to wilderness areas and trails to get away from people.

RE: "the trails don't match the activities I like to do", as primarily a mountain biker despite being close to bear creek, I don't often visit because the trails are not as fun or exciting. This property should have lots of opportunity for exciting mtb trails

If off leash dog hiking is not available/welcomed

Mountain bikes not staying on designated trails. They tend to go too fast and many expect hikers to get out of their way.

Crime and homelessness

Dogs. There are trails in Cheyenne Canon, Red Rocks Open Space, and Stratton Open Space that are unpleasant and unsafe because there are so many off-leash dogs and rotting piles of dog waste--in plastic bags, on the trails, tossed in the forests; dogs chasing wildlife, charging hikers and on-leash dogs, threatening cyclists. I know, Colorado loves dogs--I've owned and loved dogs too--but some parks are being seriously wrecked by irresponsible dog owners. Cheyenne State Park is a joy unless, as I've seen several times, dog owners rudely ignore the rules.

Overflow of people. It's hard to feel peace and nature when there are people ever ten feet. Garden of the Gods, Helen Hunt Falls, Cheyenne Canyon are all places I don't like going to anymore because of the amount of people.

Loud noises that impact serenity.

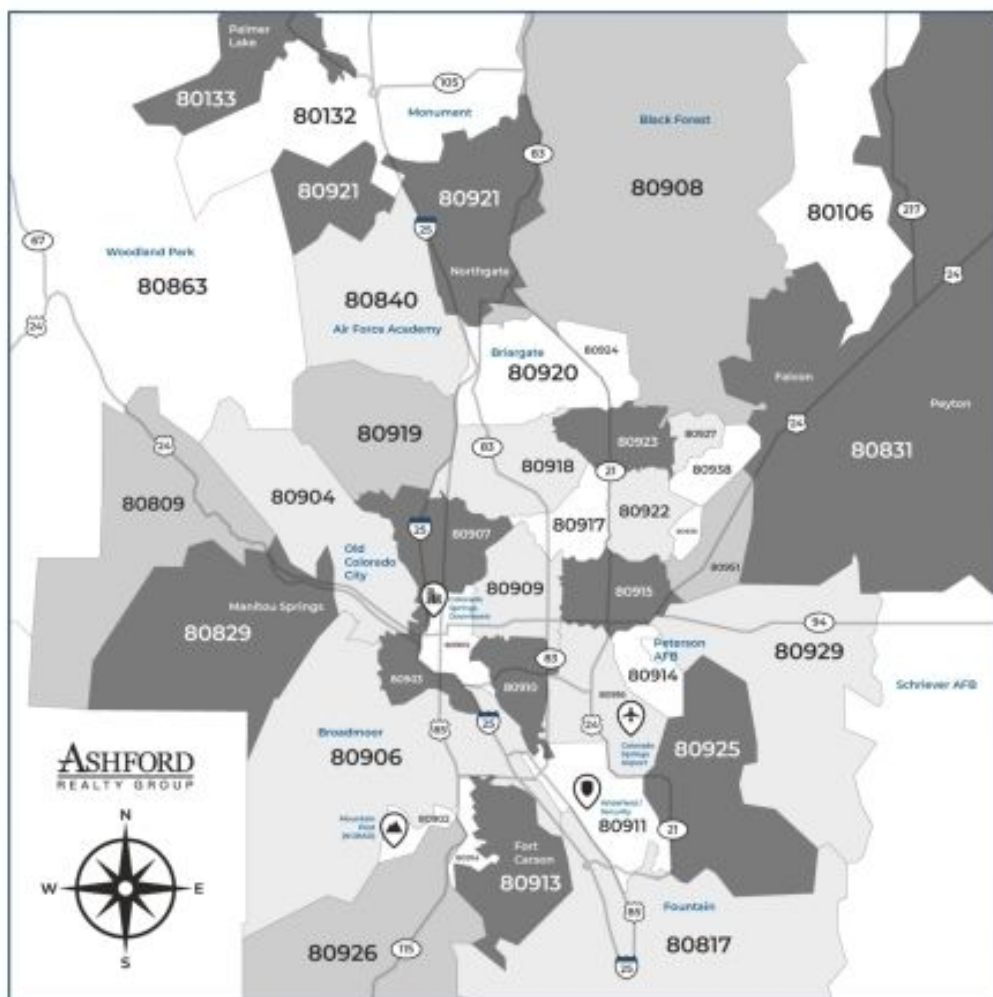
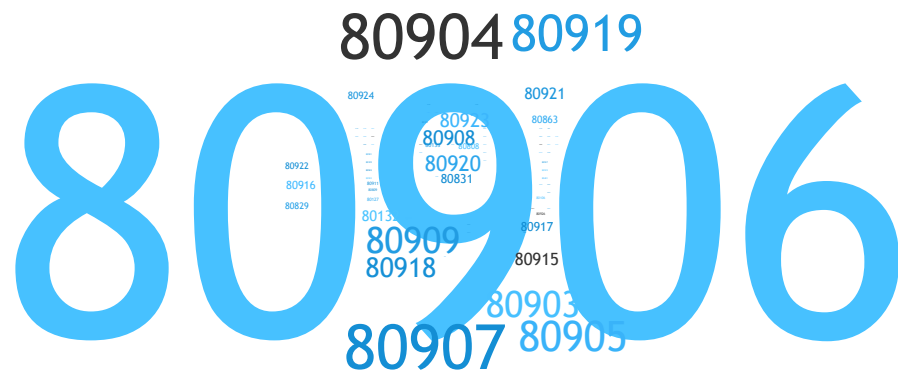
Conflict between varying users groups access and goals. The lack of specific "user group" trails... like Hike or Bike only trails.
