

BEGINNING AT THE SOUTHEASTERLY CORNER OF SAID LOT 5; THENCE ALONG THE EASTERLY LINES OF SAID LOT 5 THE FOLLOWING TWO

THENCE NORTH 00°05'05" WEST A DISTANCE OF 25.75 FEET TO A POINT OF CURVATURE;

THENCE ALONG THE ARC OF SAID CURVE TO THE RIGHT HAVING A CENTRAL ANGLE OF 90°00'00", A RADIUS OF 31.00 FEET AND AN ARC LENGTH OF 48.69 FEET (CHORD BEARS NORTH 44°54'55" EAST, 43.84 FEET) TO THE NORTHEASTERLY CORNER OF SAID LOT 5 AND A POINT ON THE SOUTHERLY LINE OF TRACT 6, RAMONA ADDITION, AS RECORDED IN PLAT BOOK L AT PAGE 56; THENCE NORTH 89\*54'55" EAST, AND ALONG SAID SOUTHERLY LINE OF TRACT 6, A DISTANCE OF 78.37 FEET TO THE SOUTHEASTERLY

CORNER OF SAID TRACT 6 AND A POINT ON THE WESTERLY RIGHT OF WAY LINE OF 19TH STREET;

THENCE ALONG THE NORTHERLY AND WESTERLY LINES OF SAID LOT 4 THE FOLLOWING THREE (3) COURSES:
