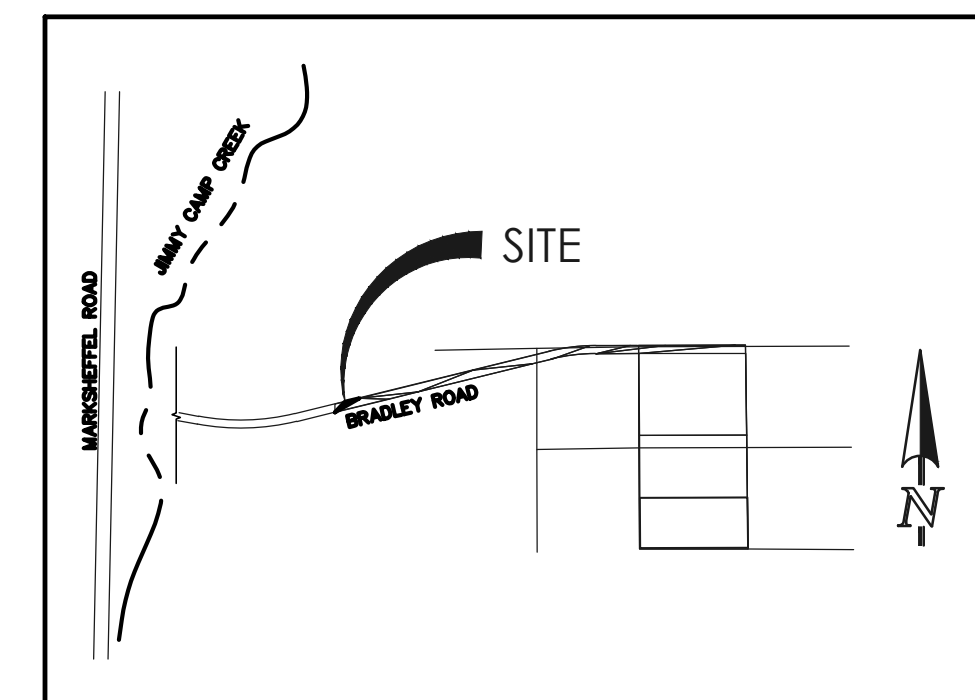


ANNEXATION PLAT AMARA ADDITION NO. 2

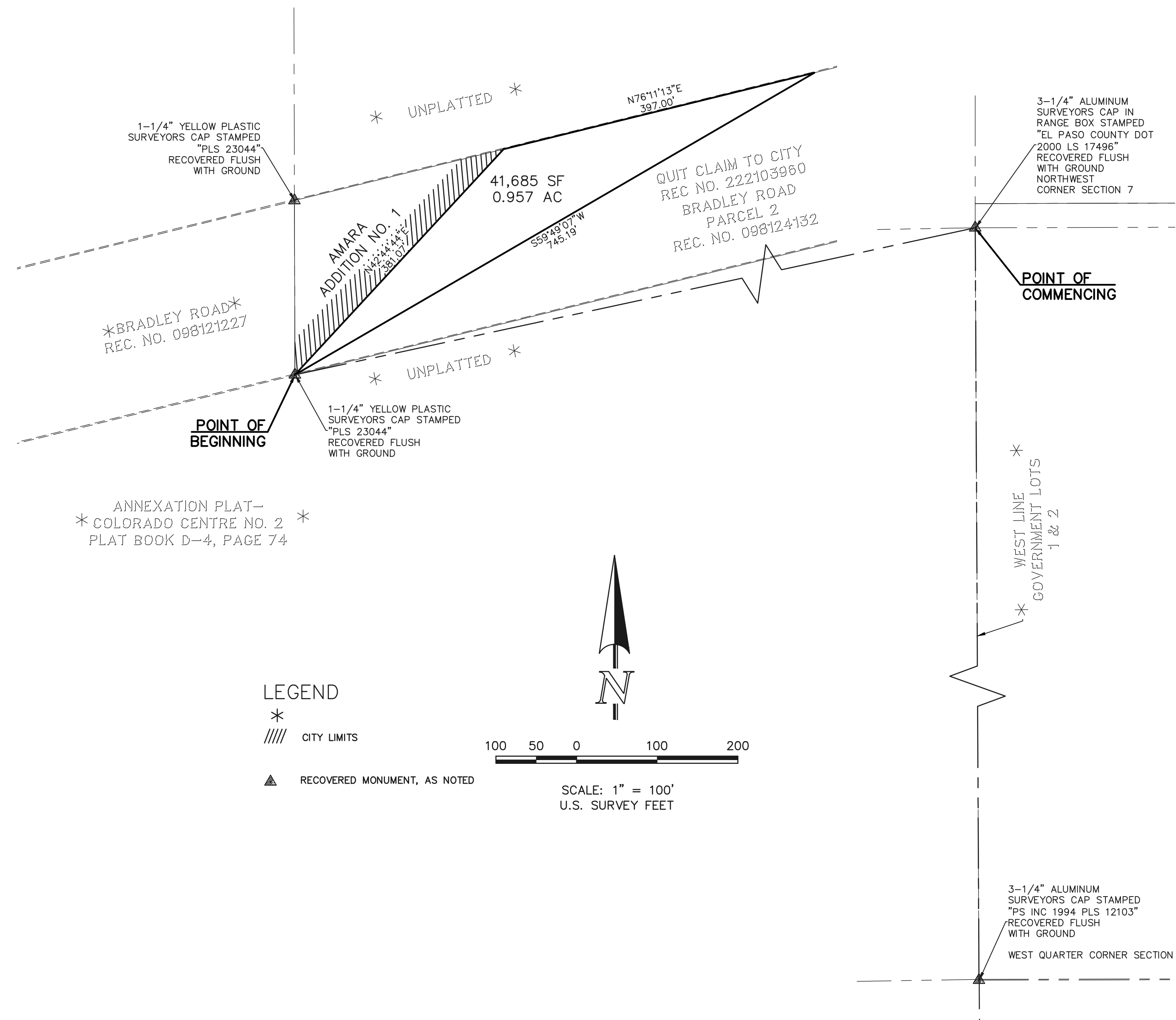
